Entry

To enter:

- 1) Open a Free Checking Account with OneAZ Credit Union for your teen (13 – 17). A parent / legal guardian must be added as a joint member on the account.
- 2) Complete the giveaway entry form on OneAZcu.com/Backpack after opening account. Entry form can be accessed by entering URL online or by scanning QR code in branch. The Parent / legal guardian or joint applicant must be 18 or older to enter giveaway on behalf of minor.
