

OneAZ Credit Union – Official Giveaway Rules Instagram Giving Tuesday

Entry

No purchase necessary to enter or claim a prize. Sweepstakes will begin Tuesday, November 27, 2018 and will end Sunday, December 2, 2018 at 11:59 p.m.

This sweepstakes is being administered by sponsor, among other means, via selected electronic and social media channels including email, Facebook and Instagram. However, this promotion is in no way sponsored, endorsed or administered by or associated with Facebook or Instagram. By participating in this sweepstakes, you release Facebook and Instagram from any and all liability arising from or related to this sweepstakes.

Participants can earn one (1) entry into the sweepstakes by:

1. following the OneAZ Credit Union Instagram account **and**
2. commenting on the designated Giving Tuesday post with the name of an organization they would like to nominate for a Community Impact Grant.

The Credit Union reserves the right to disqualify entries at its reasonable discretion. Odds of winning depend on the number of entries received.

Prize

One organization will be chosen by OneAZ Credit Union to receive a \$1,000 Community Impact Grant. The organization will be selected based on the Community Impact Grant program's key focus areas: Financial literacy, food banks, children's health, veterans' interests and local youth programs.

There will be two (2) winners for the prize of a \$100 gift card each:

1. The **first** person who **nominated** the chosen organization for the Community Impact Grant.
2. A person whose entry is randomly drawn.

The retail value of each prize is \$100. Prize cannot be exchanged for cash and is not transferable or assignable. The winner agrees to hold the Credit Union, promotional partners, officers, directors, employees, agents and representatives of each of them harmless against any and all claims and /or liabilities arising directly or indirectly from the prize and/or sweepstakes.
