Families Fighting Cancer Together | Thatcher

Families Fighting Cancer Together serves families in Southern Arizona with children battling cancer and other debilitating diseases. The OneAZ Legacy Grant provided 10 families with the support they needed to buy gifts and other holiday needs and helped to pay for essential expenses like vehicle repairs and home improvements that were necessary for the wellbeing of the child in need.

Homeward Bound | Phoenix

Homeward Bound serves Phoenix-area families facing or experiencing homelessness by providing shelter and after-care programs. Over 160 families in their Shelter and Community Services Program will benefit from the OneAZ Legacy Grant. This program provides families experiencing homelessness with access to an array of services from financial education to youth programs.

Prescott Unified School District Education Foundation Prescott

Prescott USD Education Foundation supports students and teachers by providing programs and resources that enhance their learning experience both inside and outside the classroom. This grant will help the Foundation build new "multi-sensory rooms" designed to give students a relaxing space when behavior becomes a barrier to learning.

Prescott YMCA | Prescott

The Prescott YMCA of Yavapai County provides recreational activities for members of all ages in the Prescott area. With this OneAZ Legacy Grant, the YMCA will be able to upgrade its facility to build a new Esports room for teenagers in the community. This will give Prescott-area teens a safe space to gather and have fun while working together in a competitive gaming space.
