

















Chairperson's Letter

The OneAZ Community Foundation's work is rooted in the Credit Union's mission to improve the lives of our members, associates and the communities we serve. We strive to be "A Force for Good" in our community, by supporting nonprofits, programs and initiatives that uphold our Five Pillars – Children's Health, Food Banks, Financial Education, Veterans' Interests, and Local Youth Programs.

Fulfilling our mission to improve lives.

2022 was a year of milestones for the OneAZ Community Foundation. Last year, the Foundation impacted more lives than ever before by providing over \$400,000 in donations to Arizona nonprofit organizations. This record-breaking year of giving allowed us to reach \$1,000,000 in total donations since establishing the Foundation in 2016.

New grant opportunities.

In 2022, the OneAZ Community Foundation launched the Legacy Grant program. This program allows the Foundation to allocate funds for community needs of causes that require a greater financial commitment. In its first year, the Legacy Grant program was an astounding success – we donated \$190,000 to organizations across the state.

Growing our commitment.

The OneAZ Community Foundation is committed to making an even greater impact in the communities where our members live and work. Because of our sustainable funding model, our charitable giving grows as new members join OneAZ. This model is based on members' debit card usage – each time a member uses their OneAZ debit card, the Credit Union donates one cent to the Foundation. In 2023, OneAZ is pledging to donate a record \$500,000 to Arizona nonprofit organizations.

As Chair and President of the OneAZ Community Foundation, we are incredibly proud to share the Foundation's successes with our members and community partners. Our Foundation is such an important part of how OneAZ lives up to our mission to improve lives in the communities we serve. We are grateful for your continued support and membership.

Through more personalized instruction and state-of-the-art classrooms, New Way Academy is truly changing lives for Phoenix children.

Legacy Grant Awards

In 2022, the OneAZ Community Foundation launched the Legacy Grant program. The Legacy Grant program allows OneAZ to support causes and initiatives that require a financial commitment above and beyond the grants provided in the Community Impact Grant program. Through this new grant initiative, OneAZ is able to make a lasting impact on community organizations that are uplifting the lives of our neighbors.

In 2022, OneAZ provided \$193,000 in funding to six organizations through the Legacy Grant program.
